#### **Annual Maintenance Agreement for Computer Hardware – 2024 / 2025**

#### SCOPE OF WORK AND SERVICE LEVELS - ANNEXURE 1

- 1. Annual Maintenance Agreement shall be valid for a period of one (01) year with effect from the date on which it is accepted by both parties.
- 2. Bidders are advised to offer prices separately under the **categories of Labour only** and **Labour & Spare parts (Comprehensive)**.
- 3. Onsite troubleshooting, repairing (Hardware & Software) & preventive maintenance services in respect of Desktop Computers listed **annexure 2** will be covered by this Agreement. This includes System Unit, LED Monitor, Keyboard, Mouse and Uninterrupted Power Supply Unit (UPS) connected with each Desktop Computer.
- 4. Disk cleanup & Defragmentation, updating the licensed operating system, updating the firmware on the computer systems, reinstallation of device drivers, troubleshooting the connectivity issues with other devices (Printers & Scanners) connected to computer systems and troubleshooting all types of UPS related issues will be done by the service provider as required under the agreement.
- 5. Installing, activating & updating the virus guards on the computer systems using license key given by the RRISL & cleaning the virus will be done by the service provider.
- 6. Under the category of Comprehensive (Labour & Spare parts), Annual Maintenance Agreement (AMA) will provide the replacement of all defective parts and reinstallation of operating system & other software at free of charge. Also, when necessary, data will be restored to the appropriate media provided by RRISL. Furthermore, backup unit with the same or higher configuration & specifications will be provided if it takes longer than the agreed.
- 7. **Under the category of Labour only,** Annual Maintenance Agreement will provide the reinstallation of operating system and reinstallation of other software need to be reinstalled, at free of charge. if any spare parts need to be replaced, it will be done after obtaining the approval of RRISL for the relevant estimate. If any equipment is identified to be "beyond economical repair", technical recommendation is required. Also, when necessary, data will be restored to the appropriate media provided by RRISL.
- 8. There will be no limit placed on the number of faults logged by RRISL during the duration of the Annual Maintenance Agreement.
- 9. All faults / breakdowns will be logged on designated hotline telephone numbers or email address. Also, all calls logged will be allocated a unique reference number.

- 10. Service provider shall promptly respond to service requests from Network Administrator of RRISL and take necessary steps to ensure that the fault / breakdown is rectified within specific period from the time of notification.
- 11. Three (03) routine preventive maintenance services should be conducted by the service provider during the duration of the Annual Maintenance Agreement.
- 12. Out of the two categories mentioned above, whichever category the tender is awarded under, the respective service provider is bound to perform the tasks described in Nos. 1, 3, 4, 5, 8, 9, 10 and 11 in the same manner.
